My name is Guadalupe Casas Acosta, Sr. Advisory Board Member of Cubraiti, Inc., my Traditional Mexika name is Mazatzin, my Traditional Anishinaabe name is Ogichidaa Noodin. I am an Assessor of the ancient culture of Anauak; the First Coordinador of the International Council of First Nations; an UN Ambassador of Peace & Unity, member of the CONSEJO FEDERAL EJECUTIVO NACIONAL E INTERNACIONAL DEL FRENTE MEXICANO PRO DERECHOS HUMANOS.

In the light of the recent Hawaii Supreme Court ruling against the Sovereignty of the original Nation of Atooi, Its most sacred Mountain Mauna Kea is being desecrated again...Their Language is in their Mountains, as has been expressed many times before, Culture and Nature are one and the same for First Nations Indigenous Peoples.

Madam Chair, what is affecting All of our First Nations now must be part of the Agenda and the Recommendations of the 18th Session of the UN Permanent Forum on Indigenous Issues whose theme is "**Traditional knowledge: Generation, transmission and protection**" ... and that is the **Disrespect, Desecration and Theft of our most Sacred Sites, Sacred Elements and Holy Materials -vs- Repatriation!**

UEUTLATOLLI, the ancestral word now Called Codices, which after thousands of years, with careful and respectful observation and study by thousands of Peoples across thousands of miles of our western hemisphere, came to culminate in what is universally known as the Aztek Calendar. And not just there, as it was first attained from nature and recorded in the ancient painted books of our ancestors that today are known as pre-Hispanic Codices. These Sacred Writings are being held without prior consent in the major capitals of the world, with European names, like the Borgia in the Vatican; the Dresden in Germany; the Cospi in London; the Fejervary Mayer in Paris, etc.

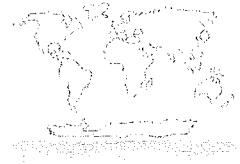

UNDRIP-Article 11 1. Clearly affirms Indigenous Peoples have the right to practice and revitalize their cultural traditions and customs. This includes the right to maintain, protect and develop the past, present and future manifestations of their cultures, such as archaeological and historical sites, artefacts, designs, ceremonies, technologies and visual and performing arts and literature.

12 2. States shall provide Redress through effective mechanisms, **which may include restitution**, developed in conjunction with indigenous peoples, with respect to their cultural, intellectual, religious and spiritual property taken without their free, prior and informed consent or in violation of their laws, traditions and customs.

One of the mission statements of our International Council of First Nations is and must be to insure and:

“Encouraging States to comply with and effectively implement all their obligations as they apply to indigenous peoples under international instruments, in particular those related to human rights, in consultation and cooperation with the peoples concerned...” Yet we see countless case of violations and lack of adherence to such international instruments ...

Now the situation and desecration of Mauna Kea, which is located on recognized First Nation land, should not be happening if there was compliance as in the UNDRIP it was stated by the majority countries of the world that “Convinced that control by indigenous peoples **over developments affecting them and their lands, territories and resources** will enable them to maintain and strengthen their institutions, cultures and traditions, and to promote their development in accordance with their aspirations and needs, recognizing that respect for indigenous knowledge, cultures and traditional practices contributes to sustainable and equitable development and proper management of the environment...”

Until First Nations once again enjoy Self Determination the Global Warming will Not be adequately dealt with... *RESPECT FOR INDIGENOUS RIGHTS IS KEY TO CLIMATE CHANGE, WE STILL REMEMBER WE ARE ONE!*

The Polynesian Kingdom of Atooi-Hawaii’s Right- Article 12 1. Indigenous peoples have the right to manifest, practice, develop and teach their spiritual and religious traditions, customs and ceremonies; **the right to maintain, protect, and have access in privacy to their religious and cultural sites**; the right to the use and control of their ceremonial objects; and the right to the repatriation of their human remains.

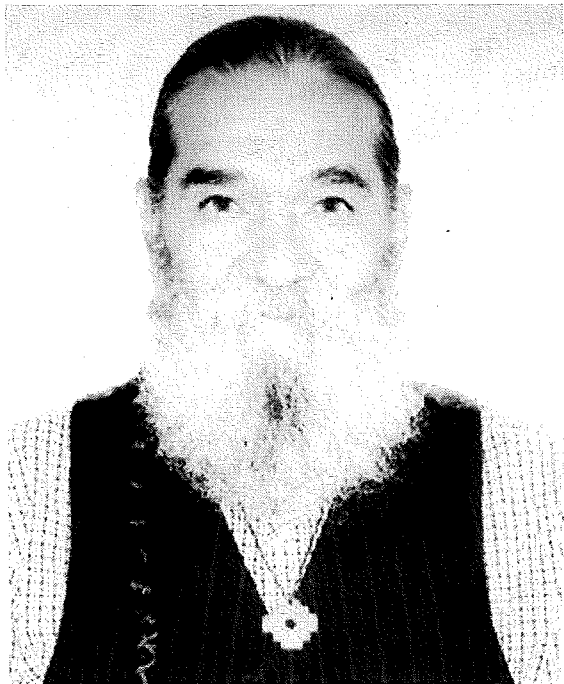
We call on the UNPFII18 to follow up on these most important issues and recommendations:

1. Letter to Pope Francisco Jorge Mario Bergoglio to inform him of our decision to begin the Repatriation of sacred Codices and Artifacts pertaining to Mexico, beginning with the Codex Borgia.
2. The Codex Borgia to be returned on the day of the 2nd passage of the Sun over the sacred City of Teotiuakan at the Temple of the Sun, the 25th of July, 2019;
3. To join with the International Council of First Nations to begin the writing of the Universal Declaration of Independence of the Sovereign First Nations.
