### **BACKGROUND**

1. At its seventh session, the Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore ('the Committee') agreed "that, immediately before the commencement of the sessions of the Committee, half-day panel presentations should be organised, chaired by a representative from a local or indigenous community".
2. These panels have since been organized for each Committee session convened since 2005, namely the eighth to the twelfth sessions. Representatives of the following organizations and the following individuals took part in a personal capacity. Almost all were directly funded by WIPO in their capacity as expert speakers. Several others were funded through the WIPO Voluntary Fund since it came into operation at the tenth session, and this has increased as the Fund has become fully established. The panels generally represent the seven geo-cultural regions recognized by the United Nations Permanent Forum on Indigenous Issues.

Describe the role of customary law, practices and protocols in sustaining and safeguarding your TK/TCEs and related GR.

Misappropriation and misuse

Describe, from your community's perspective, practical experiences with misappropriation and misuse of TK/TCEs/GR, including concerns about lack of external understanding of and respect for customary law and community values.

Community responses

Outline your community's responses to the problem of misappropriation and community initiatives to safeguard and sustain TK/TCEs/GR, including practical, legal, educational, and social responses.

Needs and expectations

Outline the needs and expectations of your community, within national system and beyond, including within the international community.

Lessons for the Intergovernmental Committee

Based on your community's experience, needs and expectations, what should the Committee pay most attention to in its work; and how can its work better meet the needs and expectations of your community?
