

During the reign of Mexican Dictator Porfirio Diaz (1876 – 1911), in retaliation for their continued resistance, Yaquis were captured and sold to plantation owners in Oaxaca, the Valle Nacional and Yucatán. At least 5,000 Yaqui were sold into forced slavery. Some, like the group in Tlaxcala where the Maaso Kova was "collected", were under direct control of the Mexican Army.

EMRIP County Engagement with Yaqui leaders, IITC, and the Swedish Museum of World Culture, March 6, 2019, Vancouver British Columbia Canada, in conjunction with the Expert Seminar on International Repatriation, 4-5 March 2020



### **Key Outcomes and Advances:**

- Recognition of Yaqui and other Indigenous Peoples' Laws, traditions and customs on an equal basis with state laws in accordance with Article 11 of the UN Declaration on the Rights of Indigenous Peoples
- The 1st International Seminar for creating a new international mechanism for repatriation based on Article 12 of the UN Declaration and the World Conference on Indigenous Peoples 2014 outcome document
- Establishment of stronger relationships among the Yaqui cultural and traditional government leaders in Arizona and Mexico, with the Sami Parliament and with the governments of Sweden and Mexico
- ...And the Swedish Museum has agreed to begin the long-awaited process for repatriation of the Maaso Kova







Despite these advances, the Sacred Yaqui Maaso Kova has still not been returned. But we know in our hearts that our Yaqui spiritual laws will prevail and he will finally come home.
