<u>United Nations – Indigenous Issues Session 6th Session</u>

Sixth Session New York, 14-25 May 2007 Agenda Item 9

Collective Recommendation submitted by the: Ethiopian World Federation, International Indigenous Historical Society, The Longhouse 1, Taitu Betul International University, Unity Washitaw, Arts International School, Genealogy and Reciprocity Reclamation.

Submission(s): (1) "We The Indigenous Peoples": Draft Bill 2007
(2) The Ethiopian World Federation International
Ecological Model City – Plan "Survival of the Forgotten".

Madam Chairperson, members of the Permanent Forum, Panelist, Indigenous people and all concerned ones.

It is the Mission of the Ethiopian World Federation to uplift our Peoples culture among its members and throughout the earth, to correct abuses, relieve oppression and carve for ourselves, and our posterity, a destiny comparable with our idea of perfect manhood and womanhood and God's purpose in creating us; that we may not only save ourselves from annihilation, but carve for ourselves a place in the Sun: in this endeavor, we determine to seek peace and pursue it, for it is the will of God for man.

Our Indigenous peoples are under continuous oppressive, colonial mandates that do not address the cause of the problems we are having today. Our Indigenous Issues are massive in all areas. Complete cultures are being assimilated and destroyed for corporate gain.

For once and for all we state that our business is about our People. How many of you here today recognize me as an Indigenous Woman, sympathize with my plight Our Indigenous cultures survived for thousands upon thousands of years with little interference. Today is different – we only see glimmers of ourselves that is if you seek it out. Culture for the Indigenous melanin peoples in America is a fleeting past time. Something must be done immediately. No more talking – Action is the resolution to our Indigenous Issues. We, the Indigenous Peoples for the Ethiopian World Federation Proclaim to assist ourselves in resolving these Indigenous Issues. We hold those responsible for the degeneration and demise of our culture traditions and self worth within the Indigenous Peoples of the Eastern and Western Hemisphere 100% responsible but we do not seek their resolutions. We only can heal ourselves and we are a well informed People with an immense amount of Higher learned knowledge and qualifications.

For two years we have been trying to awake as many peoples as possible in regards to the survival of the Forgotten (which is a platform set on re-building my peoples Indigenous Communities). Most of you here today do not recognize the ill misnomer title African American, Black, Negro, and Colored – melanin Indigenous Peoples of the Western Hemisphere as Indigenous Peoples. We I am here to remind you just incase you forgot or never thought anything about it that (WE ARE Indigenous Peoples with real Indigenous Peoples Issues).

We recommend that "Survival of the Forgotten" be considered closely for it is a realistic necessary solution to our Particular Indigenous Issues. We seek to resettle the lands of our Ancestors by establishing Economical-Social balanced communities that are built on Ecological and Sustainable foundations.

Some years ago A Great Man who is responsible for us having representation here today through the Ethiopian World Federation - brought our issues before the International Community in Geneva in regards to the many wrongs that were committed on our Sovereign Land in Ethiopia which touched the heart core within the Indigenous People of the West - mainly in America. We Call HIM Emperor Qedamawi Haile Sellassie I of Ethiopia.

He stated on that platform in Geneva, Switzerland, during that uncertain time - June, 1936.

These very words that apply to our Indigenous Issues today in the Eastern and Western Hemisphere and in the hearts of each and every person whose Human Rights have been ignored.

"The very refinement of barbarism consisted in carrying ravage and terror into the most densely populated parts of the territory, the points farthest removed from the scene of hostilities. The object was to scatter fear and death over a great part of the Ethiopian territory. These fearful tactics succeeded. Men and animals succumbed. The deadly rain that fell from the aircraft made all those whom it touched fly shrieking with pain. All those who drank the poisoned water or ate the infected food also succumbed in dreadful suffering. In tens of thousands, the victims of the Italian mustard gas fell. It is in order to denounce to the civilized world the tortures inflicted upon the Ethiopian people that I resolved to come to Geneva. None other than myself and my brave companions in arms could bring the League of Nations the undeniable proof. The appeals of my delegates addressed to the League of Nations had remained without any answer; my delegates had not been witnesses. That is why I decided to come myself to bear witness against the crime perpetrated against my people and give Europe a warning of the doom that awaits it, if it should bow before the accomplished fact."

Make it known today and forever on the Divine stage of Prophesy that our Human Rights have been ignored. Our brother's, Son's and Husbands are hunted like beast, our daughter's, sister's and mother's tears spread across the realm of the great hills creating tidal waves of dispare – for there has been no peace for our Indigenous Peoples in our own land(s). Justice has not prevailed.

Allow me to make it very clear ... We know who we are and we are proud of our children, our husbands and our culture. No longer will we sit quietly while our Indigenous are made to look like fools before the media all in the name of Corporate profit and Human Demise of a great People. No longer will we sit on the side lines while thousand are washed away into the sea without a proper response from elected leaders and silenced Indigenous Peoples who are afraid to make their voice heard. We are the Universe which makes this world tick on its axis. And we demand respect for our contribution and our sufferings and our losses and our pain.

It would be the honorable thing to do by complying with our request for full and complete Human Rights and Justice but history has proved itself to be repetitive.

Be of good courage and make it your duty to un-do the system which continues to oppress our Indigenous Washitaw Peoples here in the America's and divide us from our Indigenous Sister's and Brother's throughout Eastern Hemisphere.

May we all be encouraged to continue on the Just path of Redemption in Love and Truth for our Survival in the Universe Depends on these simple but complex values.

So without further discussion I will accept those many apologies that have trickled in from the descendants of the many oppressors that have gained immense wealth off of the backs of my people but my acceptance in honor of all my sister's and brother's come with a pay black not a pay off but a pay back.

We the members of the Ethiopian World Federation recommend the Permanent Forum on Indigenous Issues adopt...

- 1. "We the People Draft Bill 2007" for the Redemption of the Indigenous Melanin Peoples from the Eastern and Western Hemisphere whom have been abused and deprived beyond the Human imagination. A detailed list of those included are available upon request.
- 2. We also Recommend that the Ethiopian World Federation International Ecological Model City Plan "Survival of the Forgotten" for the resettlement of all Indigenous Peoples to their Indigenous cultures and traditions.

SECTION A: We The Indigenous People – Draft Bill 2007

We The Indigenous People who are miss-classified as African

American, Negro, colored, black persons and other misnomer names, are
the displaced Indigenous Washitaw, Unity Washita and Mu'urs from the
Western Hemisphere as well as displaced Indigenous Peoples from the
Eastern Hemisphere, Ityopiyawi (Ethiopian), Hebrew Israelites and many
other tribes and Nations who were Kidnapped within our Indigenous Lands,
driven from our Indigenous territories from the Eastern and Western
Hemisphere in-order to work our Indigenous lands, modernize our
Indigenous territories and cultivate our Indigenous Natural Resource for
corporate profit that would benefit those foreign invaders, oppressive

persons who kidnapped, drove, enslaved and worked We the Indigenous Melanin Peoples from the lands and territories known to our Ancestors' for many thousand years. Now we proclaim that our International Human Rights have been violated within our Indigenous homeland which has caused great destruction and demise within our Indigenous families, cultures, traditions; We the Indigenous Washitaw, Mu'urs, Dedugdahmoundyah, Ityopiyawi (Ethiopian), Israelite Hebrews and the many other Miss- Classified Melanin Tribes and Nations from the Eastern and Western Hemisphere who were ruthlessly torn from their Indigenous Homeland – Now, Proclaim that Redemption is absolutely necessary in-order that those countless wrongs immersed upon our People be made right; for our Indigenous Peoples basic dignity has been trampled on without concern nor just reason. We the Indigenous Peoples present before the United Nations Permanent Forum on Indigenous Issues this bill titled: "We The Indigenous People -Draft Bill 2007" to be added to the Second Decade on Indigenous Issue for acceptance and immediate activation. For the sound from the great Trumpet known in Zion will soon fill the four corners in Earth and throughout the realms in Heaven so may your actions be swift in the natural and just in spirit. Those many wrongs which have sieged our Indigenous rights, liberties and due processes known as Divine Law are the basis for which my

Indigenous Sister's Taalibah 'Blue Sky'Reape, Eulene Inniss, Ollie McClean, and Queen Mother Washitaw Alma Staton have presented this week in representation of just a few concerns from the Mother Womb known as Ma'at. I Emabet Hoi Akiwa Gizzel – Sandra Nelson Bey propose this bill to be activated, as listed below.

SECTION B: We The People:

Bill Will Also Be Executed For Said Countries above in sections a-7 & 8 and listed below in sections b-1 & 2.

- African countries
- South and Central American countries
- West Indies
- Also see attached list

SECTION C: We The People: Disbursement for funds

1. For such places and people known to these countries/listed in section b, do not and will not be required to migrate or relocate.

Because such is already established ... these will be recipients for the said retributions to be received. And also, such monies received will be also counted as a restitutions for moneys for Section B will also be determined according to what if any form for restoration have already been made to the land ant People. And for those monies for the land the People, and the

editors "We the Indigenous Peoples". We'll be paid or kept separately or on a percentage bases. Example: 100% paid, 10% or 15% to land for the Indigenous Peoples and 85% for the exciters.

2. Any named countries, that have reserved land or will reserve land, for the reception by We Indigenous Peoples to return and settle in \$ amount of money will be paid to such, as stated above in Section C-1: For restitution suggested amounts: for independent or established amounts \$500,000,000 million to \$10,000,000,000 million to the lands in the Americas and South and Central American isles: For the Land and Territories within the Eastern Hemisphere \$500,000,000 to \$10,000,000,000. These amounts are however left open to discussion. For an

agreed upon amount, by all parties involved.

Each country will receive agreed said

amounts holding/reserving land.

3. These monies will be used for building livable structures, for the receiving of exciters and for applications fees/paperwork that need to be processed. And for any health care expenses to the exciters. These structures to be built will allow for the privacy for families and for individuals to house until they have established a place to stay and or have built their own residences on their own chosen and settled grounds.

SECTION D: WE THE PEOPLE: (Kidnapped Captives)

Propose this to be executed for all people listed in Section A1-6 and certain of a-7 who hope for an African/Ityopiyahwi (Ethiopian) exodus.

- All doubled parent families with four to six children up to age 16: \$33 1/2 million
- Single parents with four to six children up to age 16: would be \$31 1/2 million
- 3. Doubled parent with two to three children:\$30 million
- Single parent with two to three children: \$29
 million
- 5. All single units 17 years up to 25 years: 20 million; 26-35 years: 25 million; 36 and up: 28 million
 - **5a.** Also, any single person/unit with one dependent will receive 50,000. for infants up to 12 years old, from 13 years to 16 will receive 100,000
- Any debt owed; these shall be exonerated,
 also from any and all taxes owed such as
 credit cards.
- 7. Any person or family in the exodus owning a home and is fully paid up must receive full

- and fair market value for their home. If home is not fully paid any moneys already paid that amount will be paid to owners as purchase price. Plus 10% interest.
- 8. Any persons in the exodus owning property fully paid who has a family member not in the exodus, can leave the property for that family member. However, that person exiting will not receive monies for that property. Also, any properties not fully paid left to relatives not in the exiting will be exonerated from any further payments. this will be counted to them, included in their reparations.
- 9. All transportation to desired destination shall also be provided for; for persons and their belongings. by ship or air through the Ethiopian World Federation travel Subsidiary Charter "Zion Train Gateway" and funded through the Ethiopian World

Federation Subsidiary Charter "Outreach For Life".

Section E: And For "We The People" Who Decide To Stay:

- All elderly 65 and up shall be excused from any and all taxes for their remaining natural lives.
- 2. Any persons who brought property before

 1996, that property shall be counted to you
 as fully paid for. 1996 and after, a 3 year
 deduction for payments shall be counted
 unto you. According to what you're
 monthly mortgage payments are now. Also,
 see section d-8 for property.
- 3. All such people that stay, will be exonerated for all taxes for a period of 6 years.
- 4. This section. Section e-4 is open to any programs one may want to include as a form

for reparations such as learning institution,
health care, business, housing, etc for those
who stay.

- All Double Parents/Units: with children up to 15 years of age and elderly from 55 years and up: \$25 million.
- 6. All Youth From Ages 16 TO 25: \$5 million plus \$25 thousand added for each child.
- 7. All singles from age 26-40: will be \$10 million.
- 7a. With children/from infant to 10 years \$5 thousand will be added. 11 years -14: \$12 thousand will be added.
- 8. All singles 41-50 years old: \$15 million plus the above stated in Section e-7a.

Notes – Approved Notes

To ask for commission from the opposition to study; or decide if reparation should be considered is "Irate." They know we have a claim. It is up to us to state our claim and make our demands for claims for "We the Indigenous Peoples": We the Indigenous Peoples throughout the Eastern and Western Hemisphere know exactly "what belongs to us by right" and what we have built up and all the natural resources our lands have supplied; along with our inventions, to be re-claimed, that have allowed the abusive oppressor to sit in power. So let us present our bill in this manner. "No more red tape." As we are well prepared to present many documented facts, through our many scholars, archaeologist researchers, philosophers and such.

Section F: "All Things Listed In This Section Are Not Open For "No" negotiations; the conditions are also part of our reparations, repatriations and for our restoration.

1. 1. For the named countries listed in Section B: (attached form) that have not reserved land for the return of exciters and may do so by signing on to this Bill and stating ex amount of acres to be held. In accordance with Section C 1-2 and in appliance with Section C-3.

- 2. No European Government/President will not appoint or execute any authority over "We The People" in our settlements or agreements with one another.
- 2a. (We cannot demand and take back power, while allowing European influence/rule our destiny).
- Release our rightly owed funds, currency, dividends, precious metals, oars and precious stones and return our lands are what we are standing up for.

All Countries Listed In This Bill, And Have or will must immediately cease warring against each other. For you cannot be in The Stand For Better Days, and war against yourselves (for three to seven days there must have peace and prayer among each other)

- 3. For all such security missionaries will be required to organize, for legal re-settlement by the European from Indigenous Territories all European persons out of listed territories/in the islands of the American and in African Section F-2.
- 4. No country listed that is signed on to this bill will not pay any such so called debt to Europe. European rule and influence control and rule in our country is only using our lands and resources to pay off debts owed to their own European counterparts

SECTION G: We The Indigenous Peoples: Controlling Economics.

- 1. Starting now! All transfer/exchange of currency. Regardless date on money, must be exchanged for full face value.
- 2. "We Will Have Control Over All Products and Services": In raw materials to producing ready product for market:
 - 1.1.2a: Example: Certain raw material may be purchased from our lands with the stipulations, purchasers who turn raw material into product will receive a percentage for that products profit, or will pay, more likely, a percentage for that product in sales to us.
 - 1.2.2b. Or we "turn over" these raw materials ourselves, for we do have the know how power! and if need be, we can always hire help.
- Remember the key is keeping control over all our land resources, and not let someone else come in, pretend to build

up, carry away and sell back to "We The Indigenous Peoples". Remember example 2a.

Section H: We The Indigenous Peoples: Military, Prisoners,

We The People: Military, Prisons, Policeman

- 1. Call For The Release For All our people that are political prisoners.
- 2. And if such [those] that have unjust sentence against them.
- 3. Misdemeanors, such as sale and use of drugs, theft, bad checks, blackmail, etc.
- 4. And also, any of "We The Indigenous People" that is in military service of the opposition/Europe must be relieved of duty.
- 5. As all military persons and police for "We The Indigenous" People will be in service unto we. Along with the prisoner set free shall be in service: training.

Americas - Every organization, and groups for "We the Indigenous Peoples" will be responsible for getting a copy of this draft/bill, out to the public. And obtaining signatures.

Africa - Heads and leaders must get names for each country that will sign on to this draft/bill along with how many acres they are providing.

Question - How will we know who will stay and who will go?

Answer- When the bill arrives at the home or one picks up a copy, there will be a tear off section in which they will choose, and mail it to; whoever business it will be to process the information.

Question - Who are keepers/owners?

Answer- These are the indigenous people of certain territories and lands: plus those who established settlements through early transition, etc.

Question - who will pay?

Answer - All conglomerate corporations and their affiliate agencies incorporated: for these are them who produce the politicians and lawmakers that have governed and influenced our demise through division and separation amongst we -- and this, to their benefit!

All/Every one signing on to this DRAFT/BILL from Africa to the Americaswe will cause the action- to movement by presenting this with all of "We The Indigenous Peoples" signatures.

Remember, Signatures=Power=Action=Movement!

-NOTE-

Section-I, will be for any and all documented information and cases to support our "WE People" claims. so now is the time to make ready your file folders: under the heading SECTION F "We The Indigenous Peoples: "Case Claims"

If you: "By committee" wishes on making an entry within any of the sections, you may do so by listing your additions appropriately.

EXAMPLE: section E is where you wish to add to, you will list your submission under Sec E. If agreed, then it will receive a number after the last number in the section.

NETWORKING: All leaders, groups, organizations, churches, etc. will be responsible for sending out copies. People can help by picking up their copy at any one of the locations; to be established in your city town or state. Also, 888,000 numbers can be established by any business, group to mail out copies; also a bulk rate postage can be obtained. People can help by donating large and letter sized envelopes, and stamps. And by returning your reply promptly.

All head leaders will meet to compile signatures, and for putting in order any agreed sections.
